



REGULAR MEETING

- CALL TO ORDER** The meeting of January 28, 2015 was called to order by Mayor Harry Klein at 7:30 p.m. in the Council Chambers, 6530 W.79<sup>th</sup> Street, Burbank, Illinois.
- ROLL CALL** Roll call indicated the following Council members present: Alderman Foy, Szymczak, Grider, Piznarski and Pyle. Also present: Mayor Klein, Clerk Roach and Attorney Gary Perlman. Absent: Alderman Looney, Pacella and Treasurer Viverito.
- The meeting opened with the pledge of allegiance to the flag.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Foy to approve the minutes of January 14, 2015 as presented was unanimously approved by voice vote and so declared by the Chair.
- CURRENT BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated 5 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Pyle, Piznarski, Foy, Grider and Szymczak.
- DEPT. OF PUBLIC WORKS** Alderman Szymczak made the motion seconded by Alderman Foy to approve the proposal for Asbestos Services, submitted by Abel Plus Services, Inc. for the property located at 5001 W. 79<sup>th</sup> street, Burbank, Illinois. A roll call vote indicated 5 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman, Foy, Grider, Piznarski, Pyle and Szymczak.
- Alderman Szymczak made the motion seconded by Alderman Foy to authorize the City engineer/City attorney to prepare bid specifications and advertise for bids for the demolition of all structures and parking lots on the property located at 5001 West 79<sup>th</sup> street, Burbank, Illinois. A roll call vote indicated 5 ayes and 0 nays. The Chair declared the motion carried. Voting Aye: Alderman Piznarski, Pyle, Grider, Foy and Szymczak. Mayor Klein then told the audience that the building at 5001 West 79<sup>th</sup> street is the old Cezars inn, an eyesore that has been in the city for many years and we finally got the courts to approve a demolition order so we will go ahead and demolish that entire edifice and we will then own it.
- CITIZEN'S REPORT** The Chair recognized Charles Bandusky, of 8548 S. Lavergne who was concerned what happened to Bakers Square. Mayor Klein told him that his understanding is that they are filing bankruptcy and this is probably only the beginning and other stores will be closing. His second question was 5001 and 85<sup>th</sup> street what is the status of this building as he thinks it has been empty for over 2 years and hopes there is no squatters there. Frank Kainrath said it is empty and no one is living there. Mayor Klein asked Chief Shore to check it out and also was told it is not boarded up.
- DEPT OF ADMINISTRATION** Mayor Klein then invited the Reavis students in the audience to come up front after the Council meeting is adjourned to have their class papers signed either at the front table or at the Council table.
