- CALL TO ORDER** The meeting of November 9, 2016 was called to order at 7:30 p.m. by Mayor Klein in the Council Chambers at 6530 W. 79<sup>TH</sup> Street in Burbank, Illinois
- Roll call indicated the following Council members present: Alderman Foy, Szymczak, Contreras, Grider, Pacella, Piznarski and Pyle, Also present, Mayor Klein, Treasurer Viverito, Clerk Roach and Attorney Vince Cainkar.
- The meeting opened with the pledge of allegiance to the flag.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Contreras to approve the minutes of October 26, 2016 as presented was unanimously approved by voice vote and so declared by the Chair.
- BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated 7 ayes and 0 nays. Voting Aye: Alderman Foy, Pacella, Grider, Szymczak, Piznarski, Pyle, and Contreras.
- CLERK'S REPORT** Clerk Roach reminded everyone that we will be closed Friday, November 11<sup>th</sup> in honor of Veterans day.
- DEPT. OF ZONING** Alderman Foy made the motion seconded by Alderman Piznarski to approve Ordinance No. 38-11- 16 authorizing a variation to allow the construction of a six-foot front/side yard fence at 8458 South Newcastle Avenue. A roll call vote indicated 7 ayes and 0 nays. Voting Aye: Alderman Pacella, Foy, Grider, Contreras, Piznarski, Pyle and Szymczak The Chair declared the motion carried.
- DEPT. OF ADMINISTRATION** Mayor Klein asked the indulgence of the City Council in passing Resolution No. 11-1-16 amending Section 3.6.1, Allowable Sick leave Accrual of the Civilian Handbook of the City of Burbank. Alderman Szymczak made the motion seconded by Alderman Contreras to approve the motion as outlined above. A roll call vote indicated 7 Ayes and 0 Nays, The Chair declared the motion carried.
