

REGULAR MEETING OF THE BURBANK CITY COUNCIL December 14, 2016

CALL TO ORDER

The meeting of December 14, 2016 was called to order at 7:30 P.M. by Mayor Klein in the Council Chambers at 6530 W. 79th Street in Burbank, Illinois.

ROLL CALL

Roll call indicated the following Council members present: Alderman Foy, Contreras, Szymczak, Grider, Pacella and Piznarski. Also present Mayor Klein, Treasurer Viverito, Clerk Roach and Attorney Vince Cainkar. Absent: Alderman Pyle.

The meeting opened with the pledge of allegiance to the flag.

JOURNAL

Motion made by Alderman Grider seconded by Alderman Contreras to approve the minutes of November 23, 2016 as presented was unanimously approved by voice vote and so declared by the Chair.

CURRENT BILLS Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Foy, Pacella, Grider, Szymczak, Piznarski and Contreras. The Chair declared the motion carried.

CLERK'S REPORT Clerk Roach reported that City Hall will be closed Monday December 26, 2016 and January 2, 2017 in commemoration of the Christmas holidays.

Mayor Klein reported that he has two ordinances that he would like the City Council to pass, the first one being **Ordinance 39-12-16** amending Chapter 8, Licenses and Permits, by adding Article XXVII, Invalidity of Conflicting Ordinances, in the Burbank Municipal Code. Motion made by Alderman Pacella seconded by Alderman Foy to pass **Ordinance 39-12-16** as outlined above. A roll call vote indicated 6 Ayes and 0 Nays. Voting aye: Alderman Grider, Pacella, Foy, Szymczak, Piznarski, Contreras. The Chair declared the motion carried.

Motion made by Alderman Szymczak seconded by Alderman Piznarski to pass **Ordinance 41-12-16 adopting the Early Retirement Incentive Program for employees in the Illinois Municipal Retirement Fund.** A roll call vote indicated 6 Ayes and 0 Nays. Voting aye: Alderman Contreras, Pacella, Grider, Szymczak, Piznarski and Foy. The Chair declared the motion carried.

Alderman Foy made the motion seconded by Alderman Grider to pass Ordinance 41-12-16 authorizing a variation to allow the construction of a six foot front/side yard fence at 8057 S. McVicker Ave. A roll call vote indicated 6 Ayes and 0 Nays. Voting aye: Alderman Grider, Pacella, Foy, Szymczak, Piznarski and Contreras. The Chair declared the motion carried.

Alderman Foy made the motion seconded by Alderman Contreras to approve Ordinance 42-12-16 approving a rezoning from R-1 Single Family Residence to District R-2 Limited Multi-Family Residence District to allow the use and occupancy of two, two unit dwellings on a portion of the property at 8659 S. Sayre. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Foy, Pacella, Grider, Szymczak, Piznarski and Contreras. The Chair declared the motion carried.

DEPT. OF PUBLIC SAFETY Alderman Foy made the motion seconded by Alderman Piznarski to hire police officers Michael Malkowski and Daniel Myers with Commissioner Claude Haerr of the Fire and Police Commission swearing them in. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Grider, Pacella, Foy, Szymczak, Piznarski. Mayor Klein pinned their badges on them and everyone clapped, the Chair declared the motion carried.

Mayor Klein proceeded to read their biographies beginning with Michael Malkowski being appointed to the position of police officer with the City of Burbank. He is 34 years old and married to wife Myra for 10 years. They have one son and two little girls (Anthony 7, Judy 5 and Danielle 1). Mike attended Trossoer Career Academy in Chicago. Shortly after graduating he enlisted in the U.S. Army in 2002 as a military policeman and served 12 years of active duty service. In 2014 he entered into the U.S. Army Reserves where he continues to serve.

Mike obtained an Associated degree from Grand Canyon University and also attended several advanced law enforcement courses including Military Police School, K-9 Handler Course, Criminal Investigation Special Agent Course, Child Abuse Prevention and Investigative Techniques. Mike has worked during his career as a Patrolman, Patrol Supervisor, Desk Sergeant, Narcotics and Explosive Detector Dog Handler, Special Agent, Evidence Custodian and Executive Protection for Joint Chief of Staff and Secretary of Defense. He has worked with local, federal and international law enforcement agencies during assignments in Washington State, San Antonio, TX, South Korea and Afghanistan. He comes from a family of police officers' with his cousin being a sixteen year veteran of the Chicago Police Dept. Mike will attend the Illinois State Police Academy in January. Mayor Klein congratulated him again.

Mayor Klein then read the biography of Daniel Myers who is being appointed to the position of police officer with the City of Burbank. Dan is 25 years old, single and lives in Palos Heights. He is a graduate of Marist High School and went on to receive a Bachelor's degree in Criminal Justice with minors in American culture and sociology in 2014. Dan continued his education and obtained a Master's degree in Criminal Justice from St. Ambrose University in Davenport, Iowa. While at St. Ambrose, Dan interned with the Burbank police dept. during the summer of 2012 and is currently employed part-time with the Burbank police dept. in the support services division. Dan comes from a police family, having two cousins who are detectives with the Oak Lawn police dept. Dan will attend the Illinois State Police Academy in January. May Klein again congratulated him.

DEPT. OF PUBLIC SAFETY (Cont'd) Alderman Foy says next is the promotion of Sergeant Sean Moran to Lieutenant, sworn in by Claude Haerr. Alderman Foy made the motion seconded by Alderman Piznarski. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Grider, Pacella, Foy, Szymczak, Piznarski and Contreras. The Mayor declared the motion carried.

Sergeant Sean Moran is being promoted to the position of Lieutenant. Sean is 40 years old, married with a 14 year old step-daughter and a newborn daughter who is three weeks old. Lt. Moran graduated from Andrew High School in Tinley Park. He then obtained a Bachelor's degree in Criminal Justice from Carroll College in Waukesha, WI. After graduation, he was employed with the Chicago Police Dept. for two years. Lt. Moran left the Chicago Police Dept. and became employed with the Burbank Police Dept. in 2000 as a police officer. As a Burbank police officer, he served as a department Juvenile officer, field training officer and an operator on the Combined Emergency Response Team. Currently Lt. Moran is the police department field training coordinator. He was moved to the Investigation division as a detective and assigned to the South Suburban Major Crimes Task Force and the Major Case Unit. Lt. Moran has served both as a patrol sergeant and detective sergeant and will now serve as a lieutenant the Burbank Police Department.

Alderman Foy made the motion seconded by Alderman Contreras for the promotion of Edward Jedlowski and Israel Rodriguez to Sergeant to be sworn in by Larry Fischer, Chairman of the Fire/Police Commission. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Grider, Pacella, Foy, Szymczak, and Contreras. Mayor Klein declared the motion carried.

Mayor Klein read a biography on Edward Jedlowski starting with Sergeant Jedlowski is 47 years old, married and has two children, Ethan and Aiden, he also has a mother and brother who reside in Burbank. He is a graduate of De LaSalle High School and is currently working on his Bachelor's degree in Criminal Justice at St. Josephs' University. Sergeant Jedlowski began his career with the Burbank Police Department in 2002. As a police officer he has held the position of Field Training Officer, Juvenile Officer and an operator on the Combined Emergency Response Team. He was moved to the Investigation Division as a detective. While as a detective, he served on the South Suburban Major Crimes Task Force.

Mayor Klein then read a biography on Detective Israel Rodriguez being promoted to the position of Sergeant. Sergeant Rodriguez is 38 years old, has two daughters ages 6 and 10 and is currently expecting his 3rd child in the summer of 2017. He is a graduate of Gage Park High School. After graduating he served in the United States Marine Corps in 1997 and received two meritorious unit commendations, Sea Service Deployment ribbon and a good conduct medal. He received an honorable discharge in 2001. In 2004 Sgt. Rodriguez became a police officer with the city of Riverdale, where he worked as a Field Training Officer, Detective and assigned to the Gangs and Narcotics Tactical Unit. He left the Riverdale Police Department in 2009 when he accepted employment as a police officer with the City of Burbank.

Rodriguez obtained a Bachelors' **SAFETY** Degree in Public Administration from St. Joseph University. (Cont'd) DEPT. OF Alderman Foy made the motion seconded by Alderman Piznarski to authorize the attorney to prepare an ordinance for item 16-11-2 for Jan ZONING Zielinski of 8300 S. Oak Park, Burbank, Illinois requesting a variation to install a 6' privacy fence on the front yard side set back, approved by Zoning. Alderman Foy made the motion seconded by Alderman Pacella to authorize the attorney to prepare an ordinance for item 16-11-3 for Wladyslaw Rzadlkowski of 8121 S. Mansfield, Burbank, Illinois. The petitioner is requesting to subdivide the property into two single family units. Voting Aye: Alderman Szymczak, Contreras, Foy, Piznarski, Grider and Pacella. The Chair declared the motion carried. The Chair recognized John Przytula of 8500 S. Oak Park who wanted **CITIZENS** to know about term limits and was told the City of Burbank does not REPORT have term limits. He also wanted to know if you sell your house, where do you go and was told by attorney Cainkar you file it with the recorder of deeds. The Chair then recognized Jerry Coglianese from Little Franks who wanted to know when the wall was coming down that was put up after the liquor hearing and was told by the Mayor that was a condition of the hearing and it was not coming down unless he said it was. Mayor Klein then invited the Reavis students in the audience to come **DEPT. OF** ADMIN. up front after the meeting is adjourned and that anyone at the front table or the Council Table could sign their government class papers. The Chair asked for a motion to adjourn. The motion was made by **MOTION TO AJOURN** Alderman Foy to adjourn and was seconded by Alderman Szymczak to adjourn and was agreed upon by voice vote and do declared by the Chair. The meeting was adjourned at 7:50 p.m.
