



REGULAR MEETING

SEPTEMBER 14, 2016

- CALL TO ORDER** The meeting of September 14, 2016 was called to order at 7:30 p.m. by Mayor Klein in the Council Chambers at 6530 W. 79TH Street in Burbank, Illinois
- ROLL CALL** Roll call indicated the following Council members present: Alderman Foy, Looney, Szymczak, Grider, Pacella, Piznarski and Pyle. Also present, Mayor Klein, Treasurer Viverito, Clerk Roach and Attorney Cainkar.
- The meeting opened with the pledge of allegiance to the flag.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Looney to approve the minutes of August 17, 2016 as presented was unanimously approved by voice vote and so declared by the Chair.
- CURRENT BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated 7 Ayes and 0 Nays. Voting Aye: Alderman Pyle, Looney, Szymczak, Grider, Piznarski Foy and Pacella.
- DEPT. OF ZONING** Alderman Foy made the motion seconded by Alderman Piznarski to approve Ordinance No. 25-9-16 authorizing a variation to allow the construction of a six foot front/side yard fence and wooden deck at 7955 S. Merrimac. A roll call vote indicated 7 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Piznarski, Looney, Szymczak, Grider, Pyle, Foy, and Pacella.
- DEPT. OF PUBLIC WORKS** Alderman Szymczak made the motion seconded by Alderman Looney to approve Ordinances 26-9-16, 27-9-16, 28-9-16, 29-9-16, 30-9-16, 31-9-16, 32-9-16. and 33-9-16, providing for the levy and assessment of a Tax in and for the city of Burbank for the following Special Service Areas No. 43, 44, 45, 49, 50, 51, 52, and 53 for the tax year 2016. A roll call vote indicated 7 Ayes and 0 Nays The Chair declared the motion carried. Voting Aye: Alderman Looney, Piznarski, Szymczak, Grider, Pyle, Pacella and Foy.
- DEPT. OF FINANCE** Alderman Grider made the motion seconded by Alderman Szymczak to approve Ordinance 34-9-16 levying taxes for general and corporate purposes for the fiscal year beginning January 1, 2016 and ending December 31, 2016 for the City of Burbank. A roll call vote indicated 7 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Looney, Pacella, Grider, Szymczak, Piznarski, Pyle and Foy.
- DEPT. OF PUBLIC SAFETY** Alderman Foy made the motion seconded by Alderman Pacella to approve Ordinance 35-9-16 amending Chapter 15, Traffic, Article 1, In General, Section 15-15, Load Limits on Certain Streets, of the Municipal Code for the City of Burbank. A roll call vote indicated 7 Ayes and 0 Nays, The Chair declared the motion carried. Voting Aye: Alderman Foy, Pacella, Grider, Szymczak, Piznarski , Looney, and Pyle.

Mayor Klein said he has a Resolution No. 9-1-16 Amending Section 3.1.3, Accumulation of Vacation Time, Section 3.6.1. Allowable Sick Leave- Accrual, and Section 4.5, Retirement Health Insurance, of the Civilian Handbook of the City of Burbank. which he would like the Council to approve. Alderman Pyle made the motion seconded by Alderman Foy to approve Resolution 9-1-16 as outlined above. A roll call vote indicated 7 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Looney, Pacella, Grider, Szymczak, Piznarski, Pyle and Foy.

BUSINESS**

Alderman Szymczak made the motion seconded by Alderman Looney to approve Resolution No. 9-2-16 for \$353,500 for 2017 Maintenance Material program under Public Works. A roll call vote indicated 7 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Foy, Pacella, Grider, Szymczak, Piznarski. Pyle and Looney.

Alderman Szymczak made the motion seconded by Alderman Piznarski to advertise for bids for the 2017 MFT Maintenance Material – Bulk Rock Salt Program. A roll call vote indicated 7 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Pacella, Foy, Grider, Looney, Piznarski, Pyle and Szymczak.

Alderman Szymczak made the motion seconded by Alderman Foy to advertise for bids – 2017 MFT Maintenance Material – Hot Mix Asphalt. A roll call vote indicated 7 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Pacella, Looney, Szymczak, Foy, Piznarski, Grider and Pyle.

The Chair recognized Charles Bandusky of 8548 Lavergne who wanted to know what these assessment taxes are for. Attorney Cainkar told him these are for the paved alleys. He then wanted to know when they were going to pave 87th and Lavergne to 83rd and Lavergne. He said they are doing a nice job of paving on 86th street from Lavergne to Lamon. Mayor Klein told him that the fall newsletter would be coming out soon and his part would talk about the streets throughout the city of Burbank. He said in the ten last years we have paved about 12 miles of streets and curbs in the city of Burbank. He said we can only do with the money we have coming in. He said we get money from bond issues, motor fuel taxes, block grants and other sources. Mr. Bandusky said there is more traffic on Lavergne than 86th street. Mayor Klein said every time we pave a street the residents will say how about my street. He said every spring our engineers and Public Works director, go out and go over all the streets and believe it or not there are worse streets and eventually we will get it to them all.

Mr, Bandusky said he would like to compliment Bill Trovato on getting garbage picked up at an evicted house at 8554 Lavergne so it would not stay out there for days. The house on 87th street had stained mattresses out in front and Bill Trovato got rid of them also. He wanted to know what was going on with Cezars and was told that we were still dealing with legal issues and the bank next door to them that has been empty for years. we are trying to secure. He then asked about the Mexican restaurant when it would be open. Mayor Klein told him April of last year. Mr. Bandusky said when they finally open will they

have free margaritas and Mayor Klein said he will pay for his, Mayor Klein recognized Dennis Merda of 8358 Sayre Avenue who stated that he has lived on that street for 31 years and is very tired of seeing 18 wheelers, brown UPS trucks, besides people that work in Bedford Park. He knows the police department cannot be stationed there 24 hours a day but we do have signs that say 3 ton load limit and those brown trucks must weigh 10,000 lbs. Mayor Klein says he thinks it is a 5 ton limit on the street. Mayor Klein says they are not supposed to go south on 79th street. Chief Shore said we will be issuing tickets when they violate the weight limits. Mr. Merda said how would he know that they have been ticketed and Mayor Klein said when you don't see them going south of 79th street you will know. If they start getting ticketed, I think they will stop going down that street
