- CALL TO ORDER** The meeting of January 11, 2017 was called to order at 7:30 p.m. by Mayor Klein in the Council Chambers at 6530 W. 79th street in Burbank, Illinois.
- ROLL CALL** Roll call indicated the following Council members present: Alderman Foy, Contreras, Szymczak, Grider, Pacella Piznarski and Pyle. Also present: Mayor Klein, Clerk Roach, and Attorney Vince Cainkar. Absent: Treasurer Viverito.
- The meeting opened with the pledge of allegiance to the flag.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Pacella to approve the minutes of December 14, 2016 as presented was unanimously approved by voice vote and so declared by the Chair.
- CURRENT BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated seven Ayes and 0 Nays. Voting Aye: Alderman Foy, Pacella, Grider, Szymczak, Piznarski, Pyle, and Contreras. The Chair declared the motion carried.
- DEPT. OF ADMINISTRATION** Mayor Klein asked for a moment of silent prayer honoring Marianne Viverito, sister of City Treasurer Dean Viverito, on her death this past week. The Chair recognized Charles Bandusky of 8548 Lavergne who had numerous complaints against the house next door, 8554 Lavergne - the latest resident with two viscous dogs. He also had issues with his neighbor across the street at 8533 Lavergne in regards to a truck that they park in their driveway. Chief Shore said he would investigate both of these houses tomorrow.

The Mayor recognized Brett Kamykowski 5702 West 84th Street, who has lived in Burbank for over 40 years who wondered when people complained at one meeting why it was not brought up at the next meeting. He says he has attended ½ dozen meetings and finally decided to speak. He says he sees a lot of violation, people parking in handicapped . spaces without proper handicapped cards, and people blowing past stop signs and other moving violations Mayor Klein told him if the police are not present they cannot give them a ticket, but if someone calls them about parking in handicapped spots , they will be right there. Chief Shore told him that we give out 10,000 moving violations a year and 50,000 parking violations He then wanted to know if when people are hired for the City are they given background and physic tests. Mayor Klein told them that this is required. He said he felt he asked enough for the first time he spoke.
