- CALL TO ORDER** The meeting of March 8, 2017 was called to order at 7:30 P.M. by Mayor Klein in the Council Chambers at 6530 W. 79th Street in Burbank, Illinois.
- ROLL CALL** Roll call indicated the following Council members present: Alderman Foy, Contreras, Szymczak, Grider, Pacella, and Piznarski. Also present: Mayor Klein, Treasurer Viverito, Clerk Roach and Attorney Vince Cainkar. Absent: Alderman Pyle.
- The meeting opened with the pledge of allegiance.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Contreras to approve the minutes of February 22, 2017 as presented was unanimously approved by voice vote and so declared by the Chair
- CURRENT BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye; Alderman Contreras, Szymczak, Foy, Piznarski, Grider and Pacella.
- DEPT. OF PUBLIC SAFETY** Motion made by Alderman Foy seconded by Alderman Pacella to approve Ordinance 7-3-17 amending Chapter 8, Licenses and Permits, by adding Section 8-47, License for sale of firearms of the City of Burbank. A Roll call vote indicated 6 Ayes and 0 Nays. Voting Aye; Alderman Szymczak, Contreras, Foy, Piznarski, Grider and Pacella. The Chair declared the motion carried.
- DEPT. OF PUBLIC WORKS** Alderman Szymczak made the motion seconded by Alderman Piznarski, to approve Resolution No. 4-1-17 approving a grant application for the 2017 Cook County Community Development Block Grant Program. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Pacella, Contreras, Szymczak, Foy, Piznarski and Grider. The Chair declared the motion carried.
- DEPT. OF ADMINISTRATION** Mayor Klein asked the indulgence of the City Council in approving Resolution No. 3-1-17 electing to allow service credit in the Illinois Municipal Retirement Fund to members who served in the Armed Forces of the United States of America. Alderman Szymczak made the motion seconded by Alderman Grider to approve Resolution 3-1-17 as outlined above. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Grider, Pacella, Foy, Szymczak, Piznarski and Foy. The Chair declared the motion carried.
- CITIZEN'S REPORT** The Chair recognized John Przytula of 8500 S. Oak Park who had a question about Ordinance No. 7-3-17. Mayor Klein said basically We are saying that you cannot have a gun shop in a residential neighborhood,
- He then asked about the Cook County Community Development Block Grant program. Mayor Klein said that they have a program

in Cook County which they are giving out eight million dollars and we are asking for \$500,000 and if we get it we will use the funds to pave 85th street. He then asked about solicitors coming to the door and promoting gas and electric programs. He then asked if the City was recommending anyone and the Mayor said we were not. He also told him that Chief Shore was going to have a lengthy column in the Spring newsletter coming out soon about solicitors. Mayor Klein reminded everyone to be aware of Greeks bearing gifts.

Clerk Roach said she would like to remind everyone that we have "No Solicitors" labels that they can put on their door and that they cannot bother you if you have that in place and if they do, you can call the police and they will chase them away. Mayor Klein said they are 'free'
