



REGULAR MEETING
OF THE
BURBANK CITY COUNCIL
MAY 28, 2014

- CALL TO ORDER** The meeting of May 28, 2014 was called to order at 7:30 p.m. by Mayor Klein in the Council Chambers, 6530 W. 79th Street, Burbank, Illinois
- ROLL CALL** Roll call indicated the following Council members present: Alderman Foy, Szymczak, Grider, Pacella and Piznarski. Also present: Mayor Klein, Clerk Roach, Treasurer Viverito and Attorney Michael Cainkar. Absent: Alderman Looney and Pyle.
- The meeting opened with the pledge of allegiance to the flag.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Foy to approve the minutes of May 14, 2014 as presented was unanimously approved by voice vote and so declared by the Chair.
- CURRENT BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated 5 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Szymczak, Pacella, Foy, Grider and Piznarski.
- CLERK'S REPORT** Clerk Roach confirmed that this Saturday May 31, 2014 is the last day to buy the City sticker at regular price. Beginning Monday, June 2, the stickers will be double in price.
- DEPT. OF PUBLIC SAFETY** Alderman Foy stated that the American Heart Association wants to present Chief Richard Harper and the Burbank Fire Department with the Mission: Lifeline Award, Presentation by Mr. Art Miller, Mission : Lifeline Director. Mayor Klein asked Mr. Miller to come up and make his presentation.
- Mr. Miller started out his presentation with a couple of statistics, the first one being that there are about 700,000 heart attacks in the United States per year. 200,000 are what is called (STEMI) which are most serious where the vessels are blocked 100%. There is training that helps the EMS providers identify the STEMI promptly and notify the destination center. This year they decided to start presenting awards to EMS agencies who are showing outstanding care for STEMI patients. He said that in the state of Illinois we had nine award winners this year and the Burbank fire department is one of them. He then presented the Bronze Mission Lifeline EMS recognition award to Chief Rich Harper and his department. He then explained that Mission Lifeline is the Heart Association's initiative to provide SYSTEMS of care, getting the patients through the system as quick as possible. He then explained that it is his job to work with all the agencies and he said it is working very well with the Burbank area. Mayor Klein had a question on stemi and Mr. Miller told him that they can identify if there is a 100% blockage. He then thanked Mr. Miller for his presentation and the award.
