

REGULAR MEETING OF THE BURBANK CITY COUNCIL NOVEMBER 12, 2014

CALL TO ORDER

The meeting of November 12, 2014 was called to order by Mayor Harry Klein at 7:30 p.m. in the Council Chamber, 6530 W. 79th Street.

ROLL CALL

Roll Call indicated the following Council members present: Mayor Klein (Chair), Alderman, Szymczak, Grider, Pacella, Piznarski, and Alderman Pyle. Absent: Alderman Foy, and Looney. Present also Deputy Clerk Chisholm, Treasurer Viverito, and Attorney Vince Cainkar.

The meeting opened with the pledge of allegiance to the Flag.

JOURNAL

Motion made by Alderman Grider, seconded by Szymczak, to approve the meeting of October 22, 2014 as presented was unanimously approved by the voice vote and so declared by the Chair.

CURRENT BILL

Motion made by Alderman Grider, seconded by Pacella to approve the current list of bills. A roll call vote indicated: 5 ayes, 0 nays. The Chair declared the motion carried. Voting aye: Alderman Szymczak, Pacella, Grider, Piznarski, and Alderman Pyle. Absent: Alderman Foy, and Looney.

DEPT. OF ZONING 46-11-14

Alderman Szymczak, seconded by Piznarski made a motion to approve Ordinance #46-11-14 APPROVING THE HOLY TRINITY LUTHERAN CHURCH SUBDIVISION AT 8659 SOUTH SAYRE AVENUE. A roll call vote indicated: 5 ayes, 0 nays. The Chair declared the motion carried. Voting aye: Alderman Piznarski, Grider, Pyle, Szymczak, and Alderman Pacella. Absent Alderman Foy, and Looney.

DEPT. OF ZONING

Alderman Szymczak, seconded by Pyle made a motion to approve ORDINANCE 47-11-14 TO INSTALL A WIRELESS ANTENNA AT 6034 WEST 77TH STREET. A roll call vote indicated: 5 ayes, 0 nays. The Chair declared the motion carried. Voting Aye: Alderman Piznarski, Pacella, Grider, Pyle, and Alderman Szymczak. Absent Alderman Foy, and Looney.

DEPT. OF ADMINISTRATION

Mayor Klein said he would like to declare a Proclamation for CHILDHOOD CANCER AWARENESS WEEK from November 23, 2014 –November 29, 2014. This motion was approved by a voice vote.

NEW BUSINESS

Alderman Szymczak, seconded By Alderman Pyle to award the 2014 EAB Tree removal program MFT Section NO. 14-00000-02-GM to the lowest bidder – Smitty's Tree Service. A roll call vote indicated: 5ayes, 0 nays. Voting Aye: Alderman Grider, Piznarski, Pyle, Szymczak, and Alderman Pacella. Absent: Alderman Foy and Looney.

CITIZEN'S REPORTS

Charles Bandusky of 8548South Lavergne asked why there was no activity by the reservoir, Mayor Klein explained they are still doing it but the ground had to be tested for contaminates and proper disposal. The Second Question that Mr. Bandusky asked about the old Cezars Inn, Mayor Klein explained this is going to be a TIF district to attract new business to the area. The last question that Mr. Bandusky had was what is going on with Georgiou's and Mayor Klein Said the bank is Cleaning up the property. A resident had some questions about the rental – crime free ordinance and inspections. Mayor Klein said that was passed 18 months ago to benefit the landlords and the public safety of the Burbank residents.

REAVIS STUDENTS

Mayor Klein recognized the Reavis students who were in the audience this evening. He mentioned that anyone could sign their papers for them.
