The meeting of August 21, 2024 was called to order by Mayor Dan M. Foy at 7:30 PM in the Council Chambers at 6530 West 79th Street Burbank, Il.

Lyon Coleman said a few words in appreciation to the Fire Department for their efforts in helping his father, John Coleman. John Coleman passed away a year ago and will be missed by all.
