CALL TO ORDER

BUILDING AND ZONING

Building Commissioner Hession informed City Council and the audience that for the month of April, the building department has issued 32 contractors' registrations and 114 building permits.

PUBLIC WORKS REPORT

Public Works Director Jim Burris informed City Council and the audience that the 2nd new plow truck has been delivered and the new tree program is underway and going well.

CITY ENGINEER REPORT

City Engineer Tim Geary informed City Council and the audience that the street paving jobs will start in the next week.

NEW BUSINESS

Steven Elrod, from Crunch Fitness, and his partners gave a presentation to City Council and the audience about their proposed business plan for 7750 S Cicero Avenue. Crunch fitness would like to open in the old Babies R Us location. Denied by the Zoning Commission, Crunch fitness has addressed concerns about a 24-hour gym. They have changed their hours to 5am-10pm. After the presentation they requested City Council consider passing their request, which includes a \$5,000,000.00 renovation.

Citizens Report

Burbank resident Adriana Maron, of 5842 W 78th Place, addressed City Counsel about several auto thefts she has been a victim of. Mayor Foy referred her to the Deputy Chief to see if the police can offer assistance.

Resident Frank B. of $6530~W~82^{nd}$ Street asked City Council who his Alderman was. He is in Alderman Claude Haerr's ward.

Resident Christine Barlock, of 7125 W 82nd Place, is asking for help with speeding cars on her block. Mayor Foy informed her that the Police and Public works will look into some solutions for her problem. Possibly install and "slow down" speed sign.

Reilly Washington asked City Council who the alderman is for 8150 S Cicero (Matteson's Steak House). Mr. Washington would like to open a BBQ Restaurant business in that location. Alderwoman Gagle is presiding in that ward and will speak to him after the meeting about his plans and concerns.
