- CALL TO ORDER** The meeting of February 8, 2023 was called to order by Mayor Dan M. Foy at 7:30 PM in the Council Chambers at 6530 West 79<sup>th</sup> Street Burbank, Il.

The candidate was sworn in by Fire-Police Commission Secretary Chris Wiest.

Alderman Contreras made a motion seconded by Alderman Piznarski to approve the sale of a 1999 Spartan General Rescue Squad to the Lockport Township Fire Department at a cost of \$50,000.00.
