CALL TO ORDER

The meeting of May 14, 2025 was called to order by Mayor Dan M. Foy at 7:30 PM in the Council Chambers at 6530 West 79th Street Burbank, Il.

Three companies submitted bids the lowest being Morton Salt,Inc. (\$260,790.00). The second bid opening On April 11th 2025 at city hall @ 10:15 A.M. was for the 2025 MFT Maintenance Material – Hot Mix Asphalt (500 tons). Three companies submitted bids the lowest being Lindahl Brothers Inc. (\$35,953.20). The third bid opening on April 25th 2025 at city hall @ 10:00 A.M. was for the 2025 Street Rehabilitation – MFT Section No. 25-00060-RS. Eight companies submitted bids the lowest being J. Nardulli Concrete for (\$1,635,844.70).
